FCE 2011-2012 “QUITTER” Agreement

I, _____, as a current or potential Performing Member of Folsom Cheer Elite (FCE), agree to remain on FCE as a Performing Member, at minimum, **through the entire 2011-2012 Performance Season (ending July 1, 2012).**

Since leaving the team during performance season inflicts substantial and unnecessary hardship on the team, I understand that if I choose to disregard this agreement, I shall be considered a “QUITTER,” and will as such be subject to a **\$100 penalty**. I further understand that this fee is owed immediately after officially quitting the team. If the \$100 fee is not paid within three weeks of your leaving the squad, a late fee will accrue; \$10 each week thereafter. If you leave the team without notice, after three practices we will backdate your time to the last practice you attended. The fine is to compensate for gym costs up to two months in advanced and a fee for quitting.

There will be zero toleration on this team for members who are not committed, dedicated and motivated to be on the team.

Attendance Policy:

I understand and agree with the following FCE Attendance Terms and Conditions:

- Leadership will maintain attendance records and leadership will also serve as the final say in attendance related issues.
- After three missed, no call/no show practices, you will be removed from the team and subject to pay the \$100 “QUITTER” fee.
- Members are allowed **four (4) absences** in a performance year (August 1 2011 – July 1 2012). This applies to all practices and mandatory events. Anything beyond this may result in removal from the team, making the participant a “QUITTER.”
- Tardiness and/or leaving early at practice or team events shall be recorded as 0.50 of an absence (meaning two (2) unexcused tardies &/or early departures result in one (1) absence)
- Missing an event the day of the performance, with a notable excuse will result in two (2) absences
- I understand that if I am removed from the team for attendance or disciplinary issues, I will still owe any past due balances, as well as my “QUITTER” penalty and any applicable late fees.

I understand that, as a "QUITTER," if I wish to re-join the team at a later date, I may be subject to a meeting with Leadership and an evaluation/skill verification to ensure I can be trusted to uphold my requirements as a member.

I understand that because of my actions, my spot on the team is not guaranteed and it is at Leadership's discretion whether to allow me to re-join the team or not.

If you are not prepared to be committed to this team for one year (with case by case exceptions for missing practices/events) then please do not accept a position on this team.

Agreement:

I have read and understand the above "QUITTER Agreement," and agree to abide by the policy and regulations therein. I understand that this contract is binding.
